## Terms & Conditions

The promoter, AxiTrader Limited, Suite 305, Griffith Corporate Centre, PO Box 1510, Beachmont, Kingstown, St Vincent and the Grenadines is incorporated in St Vincent and the Grenadines, number 25417 BC 2019 by the Registrar of International Business Companies, and registered by the Financial Services Authority (“**Promoter**”). 3. Defined terms have the same meaning as the Legal Documentation unless otherwise specified in these Terms & Conditions.
4. This Promotion commences December 1, 2020 00:00 Universal Coordinated Time (UTC) and ends on January 15, 2021 23:59 UTC (“**Promotion Period**”).
5. This Promotion is open to all entrants who:
  - a. are 18 years of age or over;
  - b. maintain an Account within **St. Vincent and the Grenadines** jurisdiction;
